# Welcome and Introductions:

#### **Other Business:**

There was one question from the floor. Graham Heal wished to inquire about the status of Vancouver United FC's request to enter our teams in the Metro/Selects League.

Ewen Cameron explained that it is an ongoing process. Our mandate is to obtain the right to compete at the Metro level by 2017. Currently VYSA has committed to the process of reviewing our request but has not told us when the process will begin or end. The smaller clubs in Vancouver have expressed concern but we hope to have a



forum where we can exchange information and minimize the negative impact that they foresee.
